IN CONSIDERATION OF MY BEING ALLOWED TO ATTEND THE BELOW CLASS AND TO USE THE EQUIPMENT BELONGING TO (TBSS), I EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK OF INJURY OR DEATH, WHETHER FORESEEABLE OR NOT, SUSTAINED IN CONNECTION WITH MY PARTICIPATION IN THE BELOW CLASS

Accordingly, under no circumstances will I, nor any of my heirs, distribute, guardians, legal representatives or assigns present or bring any claim for personal injury, property damage or wrongful death against (TBSS) or any officer, director, member, agent, instructor, servant or employee of (TBSS).

I also agree to a blanket release of all rights related to my audio, video, and photographic image that may arise out of my participation in the class/course listed below. This release includes any and all marketing, promotion, or advertising specific to any event that may occur anywhere and anytime on any media as later used by (TBSS, or any of its representatives or assigns.

This RELEASE shall be construed and enforced in accordance with the laws of the State of South Carolina. I understand this Release is severable and should any clause be found invalid, the rest of the Release shall remain in effect and be enforceable.
